VA Department of Environmental Quality Update

- ◆ DEQ recently notified facilities with existing underdrains or related components and an ‘end of pipe’ discharge generated by those components (not associated with an existing VPDES permit) about new guidance titled Solid Waste Landfill Underdrain Systems. Facilities are asked to compare the sampling currently required by their solid waste permit (including any Groundwater Monitoring Plan), Part A approvals, or any other mechanism and contact their Regional Office to discuss a modification to the solid waste permit for any changes that may be allowed by the new guidance (preferably prior to your next regularly scheduled sampling event). Modification of the permit to add or modify underdrain monitoring requirements is a minor “no cost” permit modification. DEQ’s goal is to modify those affected solid waste permits as soon as feasible.
- ◆ DEQ is in the process of consolidating and responding to comments received on the clarification to the Landfill Gas Regulatory Requirements. Comments were received by SWANA, SVAWMA, VWIA and Draper Aden.
- ◆ DEQ and EPA are hosting an electronics recycling workshop on Wednesday June 28, 2017. Space is still available for those interested. Contact Katy Dacey @katy.dacey@deq.virginia.gov. to RSVP.
- ◆ The DEQ Central Office move is still on schedule for October/November of this year. DEQ will be moving to the Bank of America building located at 1111 E Main Street and will occupy the 14th, 15th, 17th, and 22nd floors.
- ◆ The 2nd Landfill Odor Workgroup meeting is scheduled for July 13 at the Piedmont Regional Office. The focus of the group so far has been complaint response and monitoring.
- ◆ The Annual Solid Waste Report (SWIA) was released to the public on June 20. The total amount of solid waste received at Virginia facilities during 2016 increased by 1.3 million tons from 2015. Solid waste includes municipal solid waste, construction and demolition debris, vegetative and yard waste, and other types of waste. The total amount of solid waste from outside Virginia rose about 700,000 tons to 6.1 million tons. The total amount from within Virginia rose slightly to 15.9 million tons. Other findings of the report include:
 - Of the 22.04 million tons of solid waste reported in 2016, 12.8 million tons were municipal solid waste.
 - The total amount of municipal solid waste generated outside Virginia was about 3.5 million tons, slightly less than in 2015. Maryland, Washington, D.C., North Carolina, New York and New Jersey accounted for 98.8 percent of all waste received from out-of-state sources.
 - Of the total solid waste managed in Virginia in 2016, about 13.3 million tons were disposed of in landfills, and about 2 million tons were incinerated. The rest was managed by other means, including mulching and recycling.

Legislative Roundup

Air Program

- ◆ Final Rule for Title V program fees was published in Virginia Register May 29th, 2017. Virginia's Title V Permit Program is projected to be underfunded for fiscal year 2018. This is due to current air emission fee revenue not reflecting the actual costs of the program. The intent of this action is to comply with state and federal requirements to fully fund Virginia's Title V Permit Program. The approach is to increase Title V fees enough to fully fund the program by restructuring the existing Title V fee schedule to better reflect actual costs of the program. The increases will vary from 0% to over 450%, depending on the application type. These new fees will be effective January 1, 2018.
- ◆ Final New Source Performance Standards (NSPS) and Emission Guidelines (EG) for MSW Landfills; published August 29, 2016
- ◆ On May 10, 2017, the EPA Administrator responded to a petition filed in October 2016 by the NWRA, SWANA, Republic Services and Waste Management for judicial review and reconsideration of the Rule. In the response, the EPA stated that their intent is to implement a 90-day administrative stay and will reconsider the Rule. Because of the EPA response, DEQ's implementation of Article 43.1 that adopted Subpart Cf of CFR Part 60 will be halted until the EPA issues a final determination on their review.

Hazardous Waste Program

- ◆ Universal Waste Mercury-Containing Lamp Crushing Guidance was published February 2017. Crushing of mercury containing Universal Waste (UW) lamps has been allowed under the Virginia Hazardous Waste Management Regulations (VHWMR) by 9 VAC 20-60 since March, 2002. To receive authorization from the Environmental Protection Agency (EPA), the DEQ must demonstrate equivalency with the federal standards which do not allow crushing. Sections 9 VAC 20-60-273 and 9 VAC 20-60-1505 of the Hazardous Waste Management Regulations, adopted in December 2016 by DEQ, address equivalency. Guidance has been published to further demonstrate that crushing can be done in a protective and safe manner and that the risk of exposure from crushing is no greater than that which would be experienced at a facility that does not crush lamps.

Solid Waste Program

- ◆ LPR-SW-2016-02 Permitting, Sampling, Analysis, and Data Reporting associated with Solid Waste Landfill Underdrain Systems - Issued October 18, 2016 as Guidance Document from Division of Land Protection and Revitalization. Comments submitted to DEQ. No substantive changes made to Guidance Document. Facilities will be expected to follow published the published guidance on monitoring underdrain systems. LPR-SW-2017-## Clarification of Landfill Gas Regulatory Requirements - Vetted by DEQ to Stakeholders for comment March 27, 2017.
- ◆ DEQ has proposed a guidance document related to landfill gas monitoring and remediation plans and an update to Submission Instruction #13 - Landfill Gas Management, Remediation and Odor Plans for Solid Waste Disposal Facilities. Comments were submitted to DEQ from VWIA, SWANA – Virginia Chapter and the Southwestern Solid Waste Management Association. A productive meeting to discuss in further detail held on May 3, 2017. DEQ is currently working on changes to the referenced documents based on stakeholder feedback.
